This announcement is made by China Boqi Environmental (Holding) Co., Ltd. (the "**Company**") on a voluntary basis.

The Company is pleased to announce that, on 23 March 2018, the Company received a notification of tender award from Anhui Tendering Group Inc. (安徽省招標集團股份有限公司) informing us our successful tender of the concession operation project of flue gas ultra-low emission upgrade for two 330MW (power unit, 1MW is equivalent to 1,000kW) units in Guqiao power plant of Huainan Mining Industry Group Power Generation Co., Ltd. (淮南礦業集團發電有限責任公司). Upon multiple negotiations between the two parties, the signing of the contract was completed on 21 May 2018. Relevant details of the project are as follows:

I. Overview of Project

- 1. Name of Project: BOT project of flue gas ultra-low emission upgrade for two 330MW units in Guqiao power plant of Huainan Mining Industry Group Power Generation Co., Ltd. (the "**Project**").
- 2. Scope of Project: The two 330MW units in Guqiao power plant of Huainan Mining Industry Group Power Generation Co., Ltd. are two 330MW coal slurry, coal gangue and coal middlings combustion units which use circulating fluidized bed boilers in a coal gangue comprehensive utilization power plant in the Huainan coal field. This upgrade is required to meet the ultra-low emission standards, in which the SO2 emission concentration upon the upgrade of desulfurization system should be lower than 35mg/Nm3 (mg/Nm3 refers to milligrams per standard cubic meter, a unit of emission concentration) (standard state, dry basis, 6% O2); the dust emission concentration at the outlet of absorption tower upon the upgrade of dust collector should be lower than 5mg/Nm3 (standard state,

dry basis, 6% O2); the NOx emission concentration upon the upgrade of denitrification system should be lower than 50mg/Nm3 (standard state, dry basis, 6% O2); and the wastewater from desulfurization upon treatment should meet the zero wastewater discharge requirement. The upgrade project includes the construction of new wet desulfurization system, upgrade of denitrification system, upgrade of dust removal system, zero wastewater discharge for desulfurization system, construction of new zero wastewater discharge system for wet desulfurization, capacity increase upgrade of draft fan and anti-corrosion of funnel.

3. Operation Period of Project: 15 years

II. Parties to the Project

Huainan Mining Industry Group Power Generation Co., Ltd. is a wholly-owned controlled subsidiary of Anhui Wanjiang Logistics (Group) Co., Ltd. (安徽皖江物流 (集團) 股份有限 公司), and is primarily engaged in (among others) fossil fuel power generation, sales of slag and incinerator ash, low calorific value coal, coal slurry and coal gangue power generation infrastructure construction, production and operation.
