# ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

## SUMMARY

### Offer Price and Net Proceeds from the Global Offering

- The Offer Price has been determined at HK\$2.40 per Offer Share (exclusive of brokerage of 1.0%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$2.40 per Offer Share, the net proceeds from the Global Offering to be received by the Company (excluding the net proceeds from the sales of the Sale Shares which will be received by the Selling Shareholders), after deduction of the underwriting commissions and estimated expenses payable by the Company in connection with the Global Offering and assuming the Over-allotment Option is not exercised, is estimated to be approximately HK\$489 million. The Company intends to apply such net proceeds in accordance with the purposes as set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

### Applications under the Hong Kong Public Offering

- The Offer Shares initially offered under the Hong Kong Public Offering have been moderately over-subscribed. A total of 7,329 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** service ([www.hkeipo.hk](http://www.hkeipo.hk)) for a total of 117,241,000 Hong Kong Offer Shares, representing approximately 4.648 times of the total number of 25,223,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- It was determined that no reallocation procedure as described in the section headed “Structure and Conditions of the Global Offering — The Hong Kong Public Offering — Reallocation and Clawback” in the Prospectus has been applied. The final number of Offer Shares under the Hong Kong Public Offering is 25,223,000 Offer Shares, representing approximately 10% of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option).

### International Placing, Cornerstone Investor and Over-allotment Option

- The International Placing Shares initially offered under the International Placing have been fully subscribed. The final number of International Placing Shares under the International Placing is 227,004,000 Shares, representing approximately 90% of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option).

- Pursuant to the Cornerstone Investment Agreement entered into among the Company, Yunnan Energy Investment (H K) Co. Limited and CMB International Capital Limited, the number of Offer Shares subscribed for by the Cornerstone Investor has now been determined. Yunnan Energy Investment (H K) Co. Limited has subscribed for 49,000,000 Offer Shares, representing approximately 19.43% of the number of Offer Shares offered pursuant to the Global Offering or approximately 4.85% of the Company’s total issued share capital following completion of the Global Offering, assuming that the Over-allotment Option is not exercised. Please refer to the section headed “Cornerstone Investor” in the Prospectus for further details of the Cornerstone Investor.
- The Directors confirm that, to the best of their knowledge, information and belief having made all reasonable enquiries, no Offer Shares have been allocated to applicants who are Directors, existing Shareholders or beneficial owners of the Shares and/or any securities of the Company and the Company’s subsidiaries, and core connected persons of the Company or their respective close associates (within the meaning of the Listing Rules), whether in their own names or through nominees. The International Placing is in compliance with the Placing Guidelines (as defined below). None of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Underwriters, or their respective affiliated companies, and connected clients of the lead broker or of any distributors (as set out in Appendix 6 to the Listing Rules (the “**Placing Guidelines**”)) has taken up any Offer Shares for its own benefits under the Global Offering.
- In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters, exercisable by the Stabilizing Manager (on behalf of the International Underwriters), at any time from the Listing Date up to 30 days after the last day for lodging applications under the Hong Kong Public Offering, to require the Company to allot and issue up to an aggregate of 37,834,000 Shares, representing approximately 15% of the initial number of the Offer Shares, at the Offer Price to, among other things, cover over-allocations in the International Placing, if any. In the event that the Over-allotment Option is exercised, an announcement will be made. As of the date of this announcement, the Over-allotment Option has not been exercised.

- approximately 65% of the net proceeds or HK\$318 million will be used to expand the Group's concession operation business:
  - 1) approximately 35% of the net proceeds or HK\$171 million will be used for strategic acquisitions; and
  - 2) approximately 30% of the net proceeds or HK\$147 million will be used for the new concession projects or the upgrades of the concession projects;
- approximately 20% of the net proceeds or HK\$98 million will be used for sewage treatment, soil and solid waste treatment fields and the development of new business of non-electricity industry;
- approximately 10% of the net proceeds or HK\$49 million will be used to support working capital and other general corporate purposes; and
- approximately 5% of the net proceeds or HK\$24 million will be used for research and development expenditures, focusing on the gas treatment, water treatment, solid waste treatment and other environmental protection solutions.

Out of the 7,329 valid applications for a total of 117,241,000 Hong Kong Offer Shares:

- 7,320 valid applications for a total of 95,241,000 Offer Shares were for Hong Kong Offer Shares with an aggregate subscription amount based on the maximum Offer Price of HK\$3.60 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of HK\$5.0 million or less (equivalent to approximately 7.552 times of the 12,612,000 Hong Kong Offer Shares initially available for allocation in pool A of the Hong Kong Public Offering); and

The Offer Shares to be subscribed by the Cornerstone Investor will rank pari passu with the fully paid Shares then in issue and to be listed on the Stock Exchange and will be counted towards the public float of the Company. Immediately following the completion of the Global Offering, the Cornerstone Investor will not have any representation on the Board or become a substantial Shareholder. No special rights have been granted to the Cornerstone Investor as part of the International Placing.

The Directors confirm that the three largest public shareholders of the Company do not hold more
